## **SPECIAL MEETING OF THE BOARD OF DIRECTORS May 20, 2009**

### **MINUTES**

The Board of Directors of Regional School Unit #20 met in special session on Wednesday evening, May 20, 2009 at the Searsport Elementary School.

1. The meeting was called to order by Chairman Jean Dube at 6:00 p.m. with the following directors present: R. Andersen, A. Bagley, T. Calderwood, J. Chamberlin, J. Cunningham, D. Dakin, K. Fleming, M. Gray, A. Hammond, S. Hopkins, C. Krause, D. Riley, E. Sanders, A. Schweikert, and D. Woods.

Also present were the following administrators: RSU #20 Supt. of Schools B. Mailloux, R. Freve, B. Arthers, A. Frost, S. Inman, D. Kaymus, B. MacFarland, J. McDonald, G. Palmer, and E. Woodsome.

Also present was staff member N. Hills, Reporter T. Mitchell, and Swanville residents D. Newcomb and K. Soll.

#### 2. New Business

- 2.1 Upon motion of A. Hammond, seconded by A. Bagley, the directors voted 12-3 (Dube, Gray, Sanders opposed), to 1 (Andersen abstaining) not to accept the recommendation of reduction of one (1) teaching position at the Nickerson School in Swanville and one (1) teaching position at the Stockton Springs Elementary School, and to add funds to cover those positions to the 2009-2010 proposed budget.**
- 2.2 Upon motion of S. Hopkins, seconded by M. Gray, the directors voted 12-4 (Bagley, Dakin, Hammond, Riley opposed) to 0 to approve the Superintendent's recommendation to eliminate Items 1, 2, 3, 4, 5, 6, and 7 of the proposed budget, taking into account the approved motion to retain the elementary teaching positions at the Nickerson School and the Stockton Springs School for the 2009-2010 school year.**
- 2.3 Upon motion of E. Sanders, seconded by A. Schweikert, the directors 6-10 (Bagley, Calderwood, Chamberlin, Cunningham, Dakin, Fleming, Gray, Hammond, Krause, Riley opposed) to 0 to approve the proposed RSU #20 2009-2010 Budget. Motion failed.**

**3. With no further business, upon motion of E. Sanders, seconded by A. Schweikert, the directors voted 16-0-0 to adjourn the meeting at 7:55 p.m.**
